# EURACT Conference: Educating Doctors for General Practice / Family Medicine 2.0

We are adding a new dimension to our conference with night-time networking opportunities on



The following topics were discussed:

- 2. Information about the dynamic interactive database of CPD/CME: each country representative in EURACT is responsible to complete and update data for his/her country on the relevant webpage.
- 3. Workshops in WONCA conference, both were accepted by the Danish scientific committee:
  - Multimorbidity in family practice educational needs
  - Learning needs for cultural competence, so to better understand the role of General Practice in the care for migrant groups

# **Basic Medical Education Committee**

Natalia Zarbailova gave an overview of the current state of the paper the BME Committee had been working upon 'Strengthening/empowering GP/ FM as a medical speciality around Europe'. Stefan Wilm and Natalia will write a first draft of the article focusing on the most interesting findings and circulate it to the members.

The BME workshop in Dublin: title will be 'Be part of the solution: tackling the challenge of teaching the minimal core curriculum to

medical students'. The committee discussed the process of the workshop: this would need to be flexible depending on the number. Each participant would individually select a topic, and groups are then formed accordingly. A facilitator would be in each group, ensuring compliance with a timeframe for discussion. An electronic template or a flipchart with questions could be prepared, asking participants about their individual experience regarding which topic, why that topic, who

should teach it, and how, where and when it should be taught.

Possible topics for the future were also discussed:

- Ideas from the Dublin workshop
- Faculty development: who do we need to teach our students
- eLearning in BME in family medicine

## Short reports of Task Forces

### **Educational Resources**

Although the Task Group consists of people with much interest in the topic, few have experience in using E-tools in their teaching and almost none are experienced in developing new E-material.

What should the Task Force develop?

- 1. learning modules on topics specific to FM
  - non-clinical material;
  - modules based on Minimal Core Curriculum of EURACT.
- 2. educational material on how to create E-Learning material, that should be interactive and allowing group activity (forum, virtual classroom, lectures with audience response systems) in order to keep the benefits of sharing, such as in traditional small group teaching.
- 3. a bank of links to existing online resources, including
  - relevant content material;
  - links to other medical education sites.

For this purpose we need to recruit additional EURACT council members with experience in developing E-teaching materials. Connection with the CPD/CME committee concerning existing E-modules and with the Website Task group, as well as technical support for the development of E-material, is important.

We selected 5 topics from Minimum Core Curriculum to be transformed from traditional courses/workshop/seminars to E-teaching material, by content expert teachers from the task force:

- 1. Introduction to FM/GP as a specific medical discipline. Principles of Family Medicine: Continuity, comprehensiveness, coordination of care, by Nino Kiknadze;
- 2. Holistic approach. Bio-psycho-social model, byElena Andreeva, Natalia Zarbailov, Esra Saatci, Francesco Carelli:
- 3. Decision making based on prevalence and incidence of target, by Helena Karppinen;
- 4. Community orientation; community centred care; community needs assessment, by Nynke Scherpbier-deHaan, Francesco Carelli
- 5. Interface of primary and secondary care: Referrals, gate keeping, advocacy, by Nynke Scherpbier-deHaan, Francesco Carelli.

The appraisal task group spent time in small groups developing their appraisal skills and also explored how to comply with the requirements for certain evidence statements.



# A visit to Ukraine

Following the EURACT council meeting in Budapest, I travelled to Uzghorod in the Ukraine with Pavlo Kolesnyk, at the invitation of Professor Ivan Chopey where I spoke at a national Conference of Family Doctors on the development of FM in Europe. I was able to spend a day prior to the conference visiting local family practices with Pavlo and I attended a CME course, which Pavlo was delivering on the management of chronic pain. I spoke to the 60 GPs at this course about General Practice in the UK. At the end of my talk one of the participants said 'I wish we could swap our problems for yours'. As I found out more about the Ukraine I completely understood this comment.

Ukraine is a country with serious economic problems and a limited health service and no health insurance. Visits to GPs are free but medication and investigations have to be paid for. Provision of secondary care is patchy and care for a limited range of conditions such as diabetes, TB and HIV are provided free of charge through vertical programmes, with the inevitable problems that that causes.

There is a problem with vaccine supply throughout the country and the clinics I visited had had no vaccinations for several months. Last year there were two cases of polio in Ukraine and multiple drug resistant TB is common.

GPs in the Ukraine are paid 60 Euros per month, this forcing them to take other work to survive. Understandably medical migration is a significant problem.

Pavlo has formed a charity with friends in the USA and Netherlands to help develop GP centres in Uzghorod and his well-equipped and attractive clinic had clearly benefitted from this. He was being creative in the way he delivered care to patients and was able to offer point of care lab tests for a range of investigations at much lower cost to the patient than going to the laboratory.

I was made extremely welcome in Uzghorod and was humbled by the way in which people were endeavoring to improve the care offered to patients in very difficult circumstances.


Clinical skills teacher, preparing and conducting OSCE exam, within the specialist exam of family physicians.
